Detailed description of organisation:

The South African Society of Anaesthesiologists (SASA), the Special Interest Groups, Branches and Business Units of SASA is member association, not for gain, that is dedicated to the furtherance of the discipline of anaesthesia at both an academic and a clinical level. SASA has been in existence since 1943 and is devoted to the welfare of its members.

Member Privacy Policy:

The South African Society of Anaesthesiologists (SASA), shall take all reasonable steps to protect the personal information of members. SASA will comply with legislation and use information provided for the purpose it is intended for. Should personal information be required for any other purpose, members will be consulted on a case-by-case basis.

The type of personal information we collect:

We currently collect and process the following information:

- Personal identifiers: ID Numbers / Passport numbers / Professional Member Numbers
- Name
- Email address, contact numbers, postal address
- Practice / Employment details
- Demographics, including Race, Gender and Disability

How we get the personal information and what we use is for:

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- Application of membership
- Update of membership
- Event registration

We also receive personal information indirectly, from the following sources in the following scenarios:

- University Departments, where registrars / trainees are employed

We use the information that you have given us in order to:

- Process membership invoices
- Maintain statistics within the profession
- Distribution of The South African Journal of Analgesics and Anaesthesia (SAJAA) or other publications
- Distribute profession relevant information in the form of email and sms communication
- Event communication
- CPD processing
- Surveys

We may share this information with:

- Publication houses for the distribution of SAJAA or any other magazine subscribed to
- Safe Surgery South Africa (SSSA) for the distribution of surveys
- SASA Exco / Council where members with outstanding subscriptions are identified, follow ups conducted
- SASA AGM – Full Membership where suspension of membership is recorded.
- Congress and Event Organisers of SASA and SASA related events
- Organisations / Companies processing CPD certificates for SASA and SASA related events

Payment of Membership:

Payment may be made via Visa, MasterCard, EFT or Debit Order.

Card acquiring and security:

Card transactions will be acquired for SASA via Netcash. Netcash uses their own form of encryption, and no Card details are stored on the website. Users may go to www.netcash.co.za to view their security certificate and security policy.
